
## INTRODUCTION

The Canadian government launched its Indo-Pacific Strategy in November 2022, setting the course for Canada's engagement in this critical region for the coming decades.

The Asia Pacific Foundation of Canada's 2024 National Opinion Poll (2024 NOP), the first survey of its kind since the release of Canada's IPS, comes at a time of heightened geopolitical tensions in the Indo-Pacific and diplomatic tensions between Canada and two major powers in the region, India and China.

The 2024 NOP revisits legacy questions from past polls on topics such as Canadian perceptions of Asia, the region's economic importance, support for policies aimed at strengthening ties, and perceived threats. It also introduces new questions, including levels of trust toward specific Indo-Pacific economies.


### Level of trust toward specific jurisdictions

### **Canada's relations with China**






# Canada's impact on Asian affairs/Commonality of interests with the U.S.

# The importance of specific jurisdictions for Canada's future







Q: Do you agree or disagree with the following statement: Canada would benefit from more Asian investment?






# Support for provincial/territorial government activities in the Indo-Pacific

Q: On a scale from 1 (Not Threatening at all) to 7 (Extremely threatening), how threatening do you perceive each of these risks to Canada over the next decade?




# Intention to visit, study, or work in specified jurisdictions

## METHODOLOGY

In partnership with Leger 360, the 2024 NOP collected 3,501 valid responses across Canada from May 27 to June 18, 2024. The distribution of responses generally mirrors Canada's latest national census demographics regarding age (18-34: 25%; 35-54: 33%; 55+: 42%), gender (male: 47%; female: 52%), and residential location type (North: Yukon, Nunavut, Northwest Territories: 1%; Atlantic Provinces: New Brunswick, Nova Scotia, Prince Edward Island, Newfoundland and Labrador: 6%; British Columbia: 14%; Alberta: 11%; Saskatchewan: 3%; Manitoba: 4%; Ontario: 38%; and Quebec: 23%).

The survey included 25 questions and generally utilized 7-point Likert scale questions with a median survey completion time of 15:28. Individual demographic information gathered by the study included: age, gender, ethnicity, marital status, and geographical location. The socio-economic information collected included education level, occupation, and household income.

In some instances, values displayed may not sum to 100% due to rounding.

Slide 5 – 'Disagree' includes respondents who rated the specified countries/jurisdictions between 1 and 3, 'neutral' corresponds to a rating of 4, and 'agree' includes ratings from 5 to 7.

Slide 6 - 'Agree' includes respondents who rated the specified countries/jurisdictions between 1 and 3, 'neutral' corresponds to a rating of 4, and 'disagree' includes ratings from 5 to 7.

For the 2024 figure, Likert scale 5-7 was denoted as 'agree,' Likert scale 1-3 was denoted 'disagree,' and the neutral score was proportionally averaged across both categories. Data for 2006 and 2008 were adjusted for the missing 'do not know' option. The 2006 question specified "including in the energy sector."

Slide 12 - 'Agree' includes respondents who rated the specified countries/jurisdictions between 1 and 3, 'neutral' corresponds to a rating of 4, and 'disagree' includes ratings from 5 to 7.

Slide 14 - Based on APF Canada NOP surveys in 2012 (n = 3,129); 2014 (n = 3,487); 2016 (n = 3,526); 2020 (n = 3,519); 2024 (n = 3,501). For the 2024 figure, Likert scale of 1-7, 5-7 was denoted as 'support.'

Slide 15 - 'Not threatening' includes respondents who rated the specified countries/jurisdictions between 1 and 3, 'neutral' corresponds to a rating of 4, and ' threatening' includes ratings from 5 to 7.

Slide 18 - 'Agree' includes respondents who rated the specified countries/jurisdictions between 1 and 3, 'neutral' corresponds to a rating of 4, and 'disagree' includes ratings from 5 to 7.
